#### Conference Goals and Outcomes:

#### 1. What is the main purpose of the conference?

The conference aims to bring together stakeholders, experts, entrepreneurs, and academics both in Iran and among the Iranian diaspora to start the planning process in formulating creative and proven strategies for Iran's reconstruction. The end deliverables for this process are an Iran Reconstruction framework (structure) for better collaboration. It focuses on uniting global expertise to identify solutions that accelerate Iran's economic recovery, promote integration into the global economy, and set clear priorities for impactful initiatives. Other benefits are: Accelerate Iran's economic recovery through collaboration and innovation. Promote integration into the global economy by fostering international partnerships. Invitation to use this platform for continued innovation.

#### 2. How does this conference benefit the people of Iran?

- Improved Economic Conditions: The conference focuses on rebuilding Iran's economy, which
  could lead to more jobs, better infrastructure, and a higher standard of living for the Iranian
  people by inviting the greater Iranian experts working with the Iranian diaspora by building a
  model that is inclusive and open based on the decentralized model following an agreed
  upon evolving framework.
